Dear Mr. Kronopolus:

The Uxbridge Public Schools is working diligently to ensure the health and safety of our staff, our students, and our neighbors. This remains our top priority as a school district and community. Therefore, we have prepared a course of action to ensure that the integrity of our concerns remain intact, particularly in relation to that of asbestos removal, repair, or disturbance thereof, either through intended or accidental means.

As Superintendent, I have directed and required the Plant Management Department to designate a staff person to be trained as the AHERA Plan LEA. All maintenance workers in the Plant Management Department are required to hold current certificates in asbestos management, AHERA LEA and AHERA O&M.

In the event of suspected structural damage exposing asbestos:

- Notify Superintendent, Principal, and designated person of condition.
- Consult our AHERA management plan to identify the presence of ACBM.
- The Superintendent will notify the Town Manager.
- If asbestos is present, the area will be secured. Authorized personnel will evacuate the room and secure by closing and locking doors, shutting down hvac equipment, and installing signage to seal off room/area.
- Notify the building inspector, our asbestos advisor, DEP, and staff. All notified
 persons shall be initially contacted by phone. All notifications will be followed up
 in writing to respective parties.
- All incidents will be documented using the surveillance form contained in our AHERA inspection binder at Central Office and copy(s) inserted into the AHERA binder located at the respective school or building.

- Await further instruction from our asbestos advisor to proceed.
- A close-out procedure will follow with notification to all parties, stating remedial actions that took place.
- We currently have a health and safety report, which is made out by parties who
 feel that there is a health or safety concern. It is followed up with an inspection by
 the Plant Manager and signed off on by the Business Manager and
 Superintendent.

Construction where suspected ACBM is present:

- Area where construction is to take place must be identified.
- Our asbestos advisor must be notified in writing along with the DEP, Dept of Labor and Standards, Superintendent, Plant Manager, and Building Inspector.
- Upon completion of proposed project, all files will be made out and filed in respective binders.
- All pre and post air quality results will be filed in the binders at the respective locations including that of all disposal manifests and haulage of disturbed/ demoed materials.
- We currently have a designated person and one trained in O&M. A third person will be taking the 16 hr O&M course shortly.

We hope that these corrective measures meet the expectations of the Department of Environmental Protection. 2016 Year Re-inspection

On October 22, 1986, President Reagan signed into law an amendment to the Toxic Substance Control Act requiring schools to determine the presence of asbestos containing building materials in all school buildings. That amendment, called the Asbestos Hazard Emergency Response Act (AHERA) required that all school buildings be visually inspected by accredited inspectors and that bulk samples of suspected materials be taken where the material was not assumed to be asbestos. It further required that management plans be created for each individual building and that the maintenance and custodial personnel receive training. The plan must be implemented and the training must be completed by July 9, 1989. This document is the Asbestos Management Plan which provides the means and the methods to effectively deal with asbestos containing building materials.

All phases of asbestos inspection and management planning are reported in this plan including: response action strategy, priorities, scheduling of abatement activities and coordination of personnel and evaluation of results. The plan has an additional function as a reporting document to that State. At the local level, the plan must be made available for general review by school district.

Utilizing a stringent operations and maintenance program all asbestos containing materials are kept in good condition and the school department has taken all necessary actions to insure the safety of all buildings occupants.
