

**THE CONSTITUTION OF THE
McCloskey Middle School
Chapter of the
NATIONAL JUNIOR HONOR SOCIETY**

**Article I
Name and Purpose**

- **Section 1:** The name of the organization shall be the McCloskey Middle School Chapter of the National Junior Honor Society of Secondary Schools. (MMS - NJHS)
- **Section 2:** The purpose of this chapter shall be to create enthusiasm for scholarship, to stimulate a desire to render service, to promote admirable leadership, and to encourage the development of character and citizenship in the students of McCloskey Middle School.
- **Section 3:** The National Honor Society Constitution shall serve as the general guideline for all chapter functions, and these bylaws shall amplify sections of the National Constitution and clarify the operating procedures of the chapter.

**Article II
Membership**

- **Section 1:** Membership in this chapter shall be based upon scholarship, character, leadership, citizenship, and service. Once selected, members have the responsibility to continue to demonstrate these qualities.
- **Section 2:** The faculty council shall reserve the right to award honorary membership to school officials, principals, teachers, NJHS advisors, or others in recognition of outstanding service to the school in keeping with the purpose of the National Junior Honor Society.
- **Section 3:** Candidates become members when inducted at a special ceremony.
- **Section 4:** A NJHS member who transfers from another school and brings a letter from the principal or chapter advisor to the new school advisor shall be accepted automatically as a member in the new school's chapter. Transfer members must meet the new chapter's standards within one semester in order to retain membership.
- **Section 5:** Members who resign or are dismissed are never again eligible for membership.

- **Section 6:** Candidates for membership shall have spent at least the equivalent of two trimesters at McCloskey Middle School. The only candidates eligible for election to the chapter shall be in grade 8 and have a combined scholastic average (combined data from final grade 6 & 7 and Trimester 1 of grade 8) of an A- or above in core academic courses. Final selection of members will be based upon a combination of scholarship, leadership, service, characters, and citizenship. For the purpose of average the following numerical equivalents will be used: A or A+ = 4.0, A- = 3.7, B+ = 3.3, B - 3.0, B- = 2.7, C+ = 2.3, C= 2.0, C- = 1.7, C+ = 1.3, C = 1.0, C - = 0.7, D+ - 0.3, D or lower = 0

Article III Election and Dismissal of Members

- **Section 1:** Membership in the McCloskey Middle School Chapter of the NJHS is open to students whose standards of scholarship, character, leadership, citizenship, and service are far above those of the average student.
 - Election of members shall be based on the following criteria:
 - Criterion 1: All candidates must have attended McCloskey Middle School for the equivalent of two trimesters.
 - Criterion 2: The second consideration for membership is that students eligible for election to the chapter shall be in grade 8, and have a combined scholastic average (combined data from final grade 6 & 7 and Trimester 1 of grade 8) of an A- or above in core academic courses. For the purpose of average the following numerical equivalents will be used: A or A+ = 4.0, A- = 3.7, B+ = 3.3, B - 3.0, B- = 2.7, C+ = 2.3, C= 2.0, C- = 1.7, C+ = 1.3, C = 1.0, C - = 0.7, D+ - 0.3, D or lower = 0
 - Criterion 3: Students who have been suspended from school for any reason during the year in which they are being considered for membership are not eligible for admission to NJHS.
 - Criterion 4: Student must be a member of at least one school-sponsored club, activity, or sport.
 - Criterion 5: Student must be a part of at least community service organization IE: boy scouts, relay for life, walk-a-thons, tutoring, religious work or any program which requires volunteerism or charity Please note babysitting does NOT count as a community service.
 - Criterion 6: Student must provide at least two and no more than three recommendations. One must be filled out by a MMS staff member and one must be from an outside professional.

- **Section 2:** Guidelines and Dismissal
 - PROBATION is defined as a loss of all NJHS privileges for a period designated by the Faculty Council. Privileges include, but are not limited to, participation in all meetings, elections, or society functions. A written notice of probation will be issued by the Faculty Council, and a copy will be kept on file for future reference. No NJHS member will be issued more than one probationary

period. Any subsequent infraction will result in dismissal. For flagrant violations of civil or school rules, dismissal will result without prior probation.

- o Citizenship
 - Suspension from school will result in dismissal from the National Junior Honor Society.
 - The following offenses may result in dismissal from the National Junior Honor Society:
 - Cheating
 - Vandalism
 - Theft
 - Use of drugs/alcohol on school property or at a school function
 - Obscene acts or language
 - Flagrant disrespect of authority
 - Truancy
 - Fighting
 - Unsatisfactory citizenship grades
 - Any second cause for probation
- o Scholarship
 - Two or more grades below C on a progress report or report card will result in dismissal.
 - One grade below C on a progress report or report card will result in probation.
 - Any subsequent grade below C may result in dismissal.
 - The member is required at this time to provide explanation for academic deficiency.
- o Attendance
 - Failure to attend two (2) NJHS functions will result in probation.
 - NJHS functions include all meetings and service projects.
 - Any member unable to attend a function is required to submit a written excuse to the faculty advisor prior to the function.
- o Appeals
 - Every member of NJHS has the right to appeal to the Faculty Council for the following reasons:
 - The member feels he/she has been unjustly placed on probation.
 - The member feels he/she has been unjustly dismissed from the NJHS.
 - There exists an outstanding reason for academic non-performance.
 - There exists an outstanding reason for deficit in citizenship.
 - Any notice of appeal must be made in writing and submitted to an NJHS advisor within ten (10) school days after the receipt of probation or dismissal
- **Section 3:** When a member is dismissed, his/her emblem shall be returned to the sponsor of the chapter. Notice of such action must be reported to the National Secretary of the NJHS.

Article IV Officers

- **Section 1:** The officers of this chapter shall be President, Vice President, Secretary, and Reporter.
- **Section 2:** A majority of votes cast shall be necessary to elect any officer of this chapter.
- **Section 3:** It shall be the duty of the President to preside at the meetings of the chapter.
- **Section 4:** The Vice President shall fill the chair of the President in case of absence and otherwise assist in carrying out plans of the chapter.
- **Section 5:** The chapter Secretary shall keep the minutes of meetings, a record of business, and all records on file.
- **Section 6:** The Reporter shall be in charge of publicizing chapter activities.

Article V Supervision

- **Section 1:** The activities of this chapter shall be subject to the approval of the advisor(s) and the principal.
- **Section 2:** This chapter will operate with the guidance of the faculty council consisting of five voting faculty members appointed by the principal. The chapter advisor shall be an ex-officio, non-voting member of the council. The faculty council will meet to selection members and consider dismissal, non-selection, and warning cases.

Article VI Meetings

- **Section 1:** The regular meeting of the chapter shall be held once a month during the school year to conform to the regular program of the school.
- **Section 2:** The officers of the chapter shall be elected by the membership.
